Why the deafening silence on our previous letter dated February 11, 2009 on the above subject?

Each one of you is sworn to uphold the law and safeguard the public interest. The following laws are being blatantly violated before your very eyes:

- ✓ Pakistan Environmental Protection Act, 1997 (incl. Reg. 4)
- ✓ Sindh Local Government Ordinance, 2001 (incl. Regs. 67 70, Sixth Schedule)
- ✓ Sindh Building Control Ordinance, 1979 (incl. Section 6.1)
- ✓ Karachi Building & Town Planning Regulations, 2002 (incl. Reg. 18-4.1),

Such amenity plots cannot be allotted by CDGK for residential purposes, nor can building plans be approved by KBCA, nor can construction be undertaken without approval.

Attached are comparative satellite images, dated 2004 and 2009, which expose illegal construction on the above parks and playgrounds. This criminal activity is 'being sponsored by the local UC and Town Nazims.

We once again ask you to have this 'daylight robbery stopped' of spaces meant for public recreation and play. The matter is most urgent as construction is progressing rapidly.





## 'I Own Karachi' — and can sell it!

KARACHI, this increasingly ravaged city, has a dire history of the conversion of amenity plots to commercial and residential use.

Virtually every 'ruler' or administrator has left his mark on the exploding metropolis by giving away what was not his to give — public spaces and civic-use plots that were planned by experts for the common good.

At the Corporate Summit on Climate Change held in Karachi last Thursday, the city nazim Mustafa Kamal told a gathering of some 200 businessmen, industrialists, environmentalists, academics and NGOs that he had learnt that day for the first time of the importance of the environment. He admitted to being unfamiliar with the Environment Protection Act 1997 and with the effects of climate change.

He welcomed an offer from LEAD (Leadership for Environment & Development Pakistan) to assist him in evaluating his development strategy and his proposed solutions to the city's problems, including mass transportation, treatment of 400 million gallons per day of raw sewage presently being dumped into the sea, and the management of 10,000 tons of garbage generated daily.

Coincidentally, whilst the nazim was speaking at the DHA Golf Club, members of the MOM were passing a City Council resolution at the KMC Hall, barely eight miles away, converting over 40 acres of amenity space at Sewage Treatment Plant-2 in Mehmoodabad (located at N24051'6", E67o04'27" on Google-Earth) into a housing colony. This was done despite the protests of opposition members who foresaw "horrible devastation" if land assigned for a treatment plant expansion was swallowed up. They explained that many previous attempts to misuse and convert amenity spaces had been struck down by the courts.

In July 2008, a similar illegal conversion ('commercialisation') of a 2.5-acre space on the Clifton beach was attempted by the City Council treasury benches (over the objections of the opposition members) for use as a five-star hotel-cum-shopping complex. Earlier this month, a blitz of ads in the press announced the auction of the beach plot for a reserved price of Rs119 crores.

With seven others, I filed a case in the high court of Sindh. It was explained to Justice Gulzar Ahmed that Clifton was the only beach promenade in the city, and was protected under law as an amenity space to be used for public recreation. On recognising the merit in the argument the good judge suspended the auction that was to be held on Feb 17, and issued notice to the city government. Now, residents of the area, especially those with beach-front apartments, must join the fray to protect the environment and the beach.

Over the past three years, our City Council under the slogan "I Own Karachi!" has passed a number of resolutions converting the status of parks, playgrounds, public building plots and amenity spaces to residential and commercial use. Auctions or encroachment/conversion of such spaces are the order of the day. I have attempted on several occasions to bring these flagrancies of the law to the notice of Nazim Mustafa Kamal.

In some instances, individuals and community groups in affected areas have filed petitions in the high court and have obtained ad-interim stays. Herewith a partial list of amenity spaces in the city under attack by various mafias.

To repeat, as has been repeated time and again, amenity plots and spaces are established for the public welfare and common good of all citizens. They cannot be converted or used for other purposes.

The very concept of establishing a housing colony on an amenity park plot is an anathema, especially in a situation where there is a severe paucity of open spaces, parks and playgrounds for the burgeoning population of this city.

When Enrique Penalosa, the well-known and well-regarded former mayor of Bogota, Colombia, visited Karachi some weeks ago he rightly asked what our future generations of congested city residents will be able to do when they find that we have greedily occupied and converted most of our parks, playgrounds and open spaces. What will they think of us, their forebears? That we were uncaring, selfish and rapacious, our greed for money never slaked? He pointed out the obvious fact that wealth and other assets can be created in future, but eaten-up open spaces and parks once meant for the beneficial use of citizens can never be recreated

If the city government needs money to run its functions, it must be raised through taxes or other legitimate means, not through the illegal sale of land notified for amenity and public purposes.

My team and I are tired of battling increasing gangs of marauders determined to lay waste to Karachi — as millions of citizen bystanders, who should know better, look on silently. Perhaps the superior courts will take suo moto notice of this rape of the city and ask why the applicable laws are being brazenly flouted. Perhaps the 'silent majority' will become ashamed of their apathy and act.

We received an email titled 'Vanishing Parks of Nazimabad' (copy attached. We have attached pictures taken of the various locations in various phases of (illegal) development, along with images of the CDGK plans, and satellite images of the areas.

Construction and development on the above mentioned plots is well underway, and in some cases very close to completion. The amenity plots which are huge public spaces have been covered into private residencies with newly built houses, and all the space has been sold to buyers illegally. The above developments are clearly not necessary, since they do not cater to those desperately in need of a roof above their heads. They are nothing but money making schemes contracted by corrupt developers. It is shameful that the amenity spaces of Nazimabad, the best planned area of Karachi city in terms of park and open space

# North Nazimabad residents fast losing their parks

#### **Staff Report**

**KARACHI:** The Shehri-CBE, a non-governmental organisation (NGO), has approached higher authorities, expressing its concern about the encroachment of certain parks within the precincts of North Nazimabad Town.

The Shehri-CBE has sent letters to selective heads of authorities, containing complaints of the citizens residing in the vicinity of the encroached parks. The Shehri-CBE has also dispatched a reminder on March 28, titled 'Brazen Encroachments on Parks/Amenity Spaces in North Nazimabad', which contains the names and locations of the encroached parks. The parks include Plot ST-5/2/E (Park, 2.03 acres), ST-5/4/E (Playground, 2 acres), ST-5/1/E, (Hazoori Bagh, 1.35 acres), Plot ST-4/D, (Bagh-e-Afroz, 3.5 acres), Plot ST-1/I, (Bagh-e-Dilkusha, 2.75 acres), Plot ST-9/A, Block-A, (Bagh-e-Babar) and Plot ST-5/K (Taj Mahal Bagh, 6 acres)

In the reminder, the Shehri-CBE questioned the silence of the authorities over the previous letter and reminded them of their responsibility to uphold the law and safe-



guard public interests.

According to the NGO, the laws being blatantly violated include the Pakistan Environmental Protection Act, 1997 (incl. Reg. 4), Sindh Local Government Ordinance, 2001 (incl. Regs. 67 - 70, Sixth Schedule), Sindh Building Control Ordinance, 1979 (incl. Section 6.1) and Karachi Building & Town Planning Regulations, 2002 (incl. Reg. 18-4.1)'.

The Shehri-CBE claimed that such amenity plots cannot be allotted for residential purposes, building plans cannot be approved and construction cannot be undertaken without approval.

The NGO has also attached

comparative satellite images with the letters, dated 2004 and 2009, which expose illegal constructions on the above mentioned parks and playgrounds. Shehri-CBE has alleged that local union councils and town nazims are sponsoring this criminal activity.

In the letter dated February 11, which was sent to the Sindh Governor, Chief Minister, Local Government Minister, Chief Secretary, Environment Secretary, City Nazim and KBCA Chief Controller, the Shehri-CBE wrote that construction and development on the above-mentioned plots was well underway and in some cases was close to completion. The amenity plots, which are huge public spaces, have been converted into private residencies with newly built houses and all the space has been sold to buyers illegally.

The letter said that these spaces were originally allotted for parks and are designed and located strategically for this purpose. The government should do something to stop the illegal projects immediately and restore the plots as parks and open spaces and take the developers involved to task since official plans of the city clearly identify all the above-mentioned spaces as amenity plots.

The Shehri-CBE had received a number of complaints by citizens of North Nazimabad Town. One such complaint from a citizen mentioned that there is a green belt area that formerly hosted a mini golf course near the Board of Secondary.
