# ORDER

This application has been moved on behalf of allottees/possession holders of flats located within the residential and commercial building known as 'Nasla Tower' which has been constructed on encroached land i.e. Plot No.A-193, Sindhi Muslim Cooperative Housing Society, Karachi. The application in question is a replica of the application (CMA No.576-K of 2021) which has already been dismissed by us today. The applicants are residents of the building which has been found by us to have been constructed on encroached land and has therefore been ordered to be demolished. The fate of their case is dependent on the fate of the case of the owners of the building (Nasla Tower) and they sail and sink with them.

2. In view of the findings recorded by us in CMA No.576-K of 2021, this application (CMA No.625-K of 2021) is. also liable to be dismissed and it is so ordered. We may however observe that the allottees/owners of residential units/shops in the illegally constructed Tower (Nasla Tower) are entitled to refund of amounts paid by them towards purchase of residential units/shops within three months from the date of this order. In case, such refund is not paid within the time specified above, the claimants will additionally be entitled to claim markup/ profit/damages and will be at liberty to initiate independent legal proceedings against the recovery Nasla Tower markup/profit/damages, etc (if so advised) before Courts of competent jurisdiction for implementation of the order this Court.
