CMA No.391-K of 2020 IN CONST. P. No.9 OF 2010

The issue regarding the Kidney Hill Park was taken up by

the Court and as noted in the order dated 29.12 2020, a portion of 7.3

30.12.2020 order acres of the Kidney Hill Park is still encroached upon. Ms. Amberali, Bhai has stated that Faran Society has allotted 24 plots (plots No. 88 to 111) in the land of Kidney Hill Park, where houses have been constructed. These allotments of land in the Kidney Hill Park by the Faran Society, apparently, are illegal and ab initio void, and all the 24 plots have to be retrieved from their occupants and houses demolished for making such land into a park.

- Notice be issued to the President and Secretary of Faran Society, who shall appear before the Court on the next date of hearing.
   Notice be also issued to the occupants of the said 24 houses.
- 3. Further, it is informed by the lady that in the Overseas Housing Society, which is also adjacent to the Kidney Hill Park, some residents have started encroaching upon the Kidney Hill Park's land and are extending the area of their plots by making excavation on the slope of the hill of the Kidney Hill Park. Four plots have so far been identified, i.e., Plots Nos. 35, 41, 44 and 45. Notice be issued to the occupants of these plots.
- 4. In the meantime, the Commissioner, KMC shall ensure that all the land of the Kidney Hill Park is got vacated and all sort of constructions thereon are demolished. The Commissioner, Karachi will also make compliance of the Court order and submit report. Adjourned to a date after two weeks.

# Karachi Port Trust

# CMA No.700-K OF 2020 IN CRP No.Nil-K of 2020 in CONST. P. No.9 of 2010

- 6. Mr. Yawar Farooqi, learned counsel for KPT states that the very KPT Board is being reconstituted and the same will be done by the Federal Government in some time. He states that new Chairman of KPT has already been appointed, who has taken the charge. On our question Mr. Yawar Farooqi, learned counsel for KPT states that KPT is functioning.
- In this view of the matter, let the Chairman, KPT make compliance of the Court's order and immediately start work of plantation of Mangroves on this land and before doing so, remove all the sand, which has been dumped on this land and bring it to the level of sea tides, so that, the sea water can easily enter upon the Mangroves and further flow up to the limits of Bath Island. Compliance in this regard be made in one month time and report be submitted to the Court in the hands of the Chairman, prior to the next date of hearing.

# C.M.As No.334-K, 21-K and 700-K of 2020

8. These applications seek review of the clarification of order dated 12.08.2020 in respect of KPT land adjacent to Mai Kolachi Road. Learned counsel for the petitioners/applicants state that they may be made entitled to claim compensation/damages from whom the plots in question were purchased by them. To the extent of this submission, the order already provides for the relief to the petitioners/applicants. Now what is being said is that the petitioners/applicants may be allowed to claim compensation/damages from all the previous owners of the plots, including KPT. We may note that in our order this very aspect of the matter has already been dealt with but the liability of KPT to its allottees has been fixed.

Be that as it may, the petitioners/applicants make their claims, which will be decided by the Court in accordance with law.

The applications in the above terms stand disposed of.

The Director General, SBCA, present in Court, states that he will provide maximum assistance to the Commissioner, Karachi, for completing the task of demolition of building and removal of Malba from that land. Further, the SMBR is also directed to provide necessary staff and machinery to the Commissioner, Karachi, for facilitating early completion of demolition work of the building so also removal of Malba from it. After buildings are demolished and Malba is removed, this land will be converted by the Commissioner, Karachi, into a park and he will immediately start plantation of trees and creating of green areas in it. No part of this land shall be used for commercial purposes nor any permanent structure will be allowed to be constructed in it. So for the case of the allottees of Royal Park is concerned, it is stated by Mr. Salahuddin Almed, learned counsel for the applicants that both the owners of the buildings have fled away from the country and the allottees find themselves in a situation, where they may not be able to make much recovery. He contends that the builders of Royal Park have another property in the process of being built, of which none of the units have been sold and it is named as Creek Side Shopping Centre, Phase-VIII, DHA, Karachi, on five acres of the land, Learned counsel has read documents to show that the builders of Royal Park are ciabuilders of this project also.

Nothing seems to have been done in respect of removal of the construction from Postal and Telegraph Colony (P&T Colony) and even we note that the land given to the Pakistan Navy for maintenance of its cantonment, has been leased out to private persons and huge buildings have been constructed all along the Chaudhry Khaliq-uz-Supreme Court of Patels Court of Patels Court on Road, Karachi. Such buildings, apparently, are illegally constructed and in any case, the cantonment land cannot be used for construction of private buildings or private houses by the private owners, and even we find that categorization of cantonment lands,

apparently, runs contrary to the provisions of the Constitution of Pakistan, which needs to be examined threadbare.

Order XXVII-A CPC read with Order XXIX of the Supreme Court Rules, 1980 for assisting the Court, regarding all cantonment lands and also regarding land of P&T Colony, which land belongs to the Federal Government and on which there existed quarters for the employees of P&T Office and now there are more than 250 multistoried buildings constructed, and such buildings are in the process of being occupied.

24. The Federal Government should immediately take steps for removal of the constructions on the land of P&T Colony and restore the same for the purpose for which it was originally meant for. The Federal Government, in this respect, shall file a report before this Court in one month's time.
