Report has been filed by the Commissioner Karachi by way of CMA No.16-K/2021 regarding encroachment at Haji Limo Goth, Gulshan-e-Iqbal, Karachi. The Commissioner Karachi states that Nala is 30 to 35 feet wide and most of the encroachments on Nala have been removed and further clearing of Nala is going on and all encroachments and illegal constructions on and around the Nala will be removed.

CMA No.74-K OF 2020

So far as the question of expansion of the Sindh High Court at Karachi and making provision for parking of vehicles of lawyers is concerned, we are informed that two vacant plots exist on the right and left side of the Sindh High Court building at Karachi and Sindh Government proposes to build expansion blocks of Sindh Secretariat.

We may note that the present Sindh High Court building at Karachi has already become incapable of accommodating the strength of the sitting Judges and looking at future increase in the strength of the Judges of the Sindh High Court, there is no room for expansion within the building in Karachi, rather such expansion has to be made on the available land, which is situated on the right and left side of the building. Parking concerns of the lawyers and litigants can also be addressed.

We may note that access to justice is a Fundamental Right of the people of Pakistan and such a right also includes provision of Courts. Thus, for meeting this very Fundamental Right, the Sindh Government is bound under the Constitution to make provision for expansion of the Sindh High Court at Karachi and provide land to it for doing so. It is obvious that the Sindh High Court at Karachi cannot be shifted from where it is situated now and its adjacent lands, which are vacant, are the only option where new blocks of the Sindh High Court building at Karachi can be constructed and provision for parking of vehicles for lawyers and litigants can be made.

Senior Port

In these circumstances, there appears to be no option but to retain the two plots of land; one at the right and the other at the left side of the Sindh High Court building at Karachi for its future expansion and in this regard the Sindh Government shall fulfil the Constitutional mandate for this provision. The Sindh Government shall not create any third party interest or construct any sort of a building or structure on the said two pieces of land until the matter regarding expansion of the Sindh High Court building at Karachi as well as the parking space for the lawyers

and litigants is resolved.
