- 1. The meeting started with the recitation of Holy Quran by Mr. Allah Rakha Asi, Director General, KDA. Secretary HTP, Chairman Oversee Committee Chaired the meeting, regrets of Mr. Abdul Samad Khan Rep. of NED for not attending the meeting due to the engagement in the examination of the University was granted by the Committee.
- 2. Minutes of the meeting dated 15/11/99 were confirmed with the following addition / corrections
  - a) Point No.6, Line-9, addition " to which SHEHRI objected and showed the relevant rules and regulations which clearly mention the plot ratio as 1:4 on the said plot.
  - b) Point No.6 Line-16, addition " Shehri stated that it has not received the said list and requested ABAD for a copy of it.
  - c) Point No.13, at the end of para addition "Shehri requested to supply the report sent to DG, KDA against DCB Mr. Mehmood dated 15/09/99.
  - d) Point No.14, line-2: word 'measure instead of 'measurement'.

3. Minutes of meeting dated 25/11/99 were confirmed.

4. Regarding Plot No.4 RC-6, DG, KDA informed that the said case was included in the list where relaxation were allowed and the same were cancelled by the then Government. After which a summary was moved and the same were restored after the approval of the Chief Minister, Sindh. Shehri objected and said that if anything was done against the law, then the same could be revoked or withdraw in the light of judgement of Supreme Court of Pakistan in the case of 'COASTA LIVINA". It was decided that a summary will be sent to the Government for cancellation.

Mr. Nooruddin of PEC proposed that a sub-committee to be formed to lookafter such cases and put up his recommendation to the Oversee Committee, so that the time of Oversee Committee is saved. However, ABAD objected on it and said that dragging out such type of case is un-necessary as the case is very old and he further said that main reason behind these cases are

out-dated Building & Town Planning Regulations and stressed that the same should be updated on urgent basis.

It was therefore decided that a Committee comprising (1) Mr. Saleem Thariani and (2) Mr. Nooruddin Ahmed shall workout the para-meter to define the categorization of such cases, which may be taken up in the Oversee Committee.

5. Shehri pointed out that their letter dated 16.11.1999 in respect of 83 F, Block-2, PECHS was not replied by the KBCA as yet. Secretary, HTP said that these types of the issues be taken up initially, at the level of Chief COB, so that the time of the Committee is not wasted. PCATP said it is in the purview of the committee to see if there is any irregularities committed and to undo these illegalities. ABAD stated that all the irregularities relate to out-dated Karachi Building & Town Planning Regulations. PEC & PCATP asked to take action against the concerned that had committed the irregularities. It was therefore decided that sub-committee as formulated in item 4 above shall take up this issue also and submit his recommendation.

6. Regarding implementation of the decision of the committee in respect of project "NICE TRADIORBIT" in item-9 of (22+) 10<sup>th</sup> meeting for cancellation of amalgamation/plan etc, DG. KDA/CCOB told that permission for cancellation is to be obtained from the approving authority. Therefore it was decided that a summary be put up for cancellation of the same to the authority who allowed it through Chairman/ Secretary, HTP. ABAD dissented and said that the law devised 20 years ago can not provide any relief to the citizen. ABAD further said that a yardstick to be drawn and ensured that ABAD shall take action against their members in future if they found involved in any irregularities.

7.
