plot No.150-F, has been sealed and no construction activity on it is in progress. Mr. Sultan Mohammad Zuberi COB (F) and Mr. Badar us Salam Baig, COB(D) informed about action taken in their areas and short coming faced by them in completing the task. Mr. Nooruddin Ahmed of PEC said that the demolition action taken by the KBCA are not upto the mark as the KBCA in the absence of mechanical and scientific arrangement can not to take up the task properly. He said that keeping in view of the realities, the sub-committee suggested to take the services of FWO who has skilled manpower and equipment to deal but unfortunately it is informed that the FWO has regretted to take up the task. Chief COB informed that he will contact with the other consultant dealing with the subject in order to assign them to take demolition action mechanically and scientifically.

It was therefore decided that in future all the Controller of Buildings shall present to the Oversee Committee the detail of the demolition action taken alongwith the photographs and other details and description of the action in their respective area.

not apply on the subject case. Further the building plan of subject has been canceled and the a case is also pending in court. It was therefore decided that the approval of said plot should not be restored till such time the condition of approval are complied by the applicant as per law.

It was also decided that plots where amalgamated, sub-divided, change of land use and approval of building plan is granted conditionally, no further action shall be allowed till the completion of the conditions and if construction has been started, the same shall also be stopped. Further no conditional approval of any type shall be approved. It was decided that in all such cases letter to the lessor shall be issued by the KBCA stating that further processing of case shall be initiated on the receipt of permission from the lessor and the copy of the same shall be provided to the applicant.
