Meeting started with the recitation of Holy Quran by Mr. Akhter Iqbal Usmani, DG, KDA chaired the meeting and in his inauguration message said it is an honour for him to be the member of this august committee. He further said that he being the resident of the City is well aware about the problems faced by the citizen of the Karachi and assured to do his best to solve these problems and to up-hold the supremacy of law with the co-operation of the members of the committee.
- 2. Minutes of the (22+)16th meeting were confirmed with the following addition/correction.

Addition in para-3.

- (i) It was suggested by DG, KDA that whenever COB/DCB/ACB carries out a visit of a zone or COB(Demolition), he would make entry in the diary and on return would enter whatever demolition has been done, so that proper progress record of demolition would be maintained and be available.
- (ii) In para No.10, line No.7, work "restored" replaced by "given".

Action: Members of Oversee Committee.

3. Members showed their concerned for not completing the task of demolition as mentioned in the para-3 of the minutes of (22+) 16th meeting and as well as referred in the resolution No. 9/99. In this connection Mr. Kalimuddin pointed the example of plot no. 76-P, Block-2, PECHS, Karachi and said that the action has not been taken by the concerned circle even after passing considerable time and thus allowing people to occupy the building. It was therefore decided that a list of the buildings constructed in violation of approved plan from 1998 shall be prepared by KBCA and to be submitted in the next meeting. Further demolition action shall initiated on the 57 buildings on which the court has ordered for demolition and the buildings mentioned in the resolution no. 29/99 and compliance report shall be submitted in the next meeting. ABAD dissented from it and said that demolition should be stopped till the time a policy decision about the buildings constructed in violation of approved plan is taken, otherwise all such buildings should be demolished in-discreminationary.

As Regulations may also be taken into task. Action: All COBs / Chief COB.

4. Regarding plot NO. 220, J.M. Quarters Mr. S.M.R.Zaidiul Wasti, informed that the preliminary enquiry has been completed and file has been sent for taking decision of it to the CCOB/DG(KDA). However, other action i.e. publication of notice in the newspapers and serving of notice for demolition to the owner has been taken. Further the COB(D) informed that owner has started the demolition of unauthorized construction on the portion of the building constructed in violation of the plan. M/s. Shehri objected that owner can not be allowed to demolish the building himself without having plan of demolition and supervision of professional and showed their apprehension that owner shall complete the buildings under the shelter of demolition to induct the occupants. COB(D) assured that the unauthorized portion of the building shall be demolished. Further it was decided that the licence of professionals involved in the said case be suspended immediately. Latest report of demolition of the building with photographs shall be submitted in the next meeting of Oversee Committee.

Action: COB (D) / Chief COB.

5. Mr. Badar Salam Baig informed the committee the difficulties being faced by the officers in completing the task of demolition and said as per resolution No. 29/99, about all the buildings in his circle have been demolished. He further said that on verbal orders of DC, Commissioner and higher ups etc. the demolition action was suspended. Mr. Kalimuddin, Chairman, PCATP also said the behavior of district administration with the KBCA officers is not up to the mark and they always create hinderance in performing their duties by wasting their time. In this regard Mr. Qazi Faez Isa quoted resolution No. 2/2000, in which it is stated that if an officer has any difficulty, they shall inform the same to the Chief COB who will resolve the matter. He further said, KBCA officers are not bound to obey the verbal order from any quarter.

Action: All COBs / Chief COB.

6. Dr. Gardezi pointed out that the unauthorized construction on Plot No. 42 and 42-A, Adamjee Nagar Karachi has not been demolished. The DG, KDA directed KBCA that progress report along with photographs should be submitted in the next meeting.

It was therefore decided that a list of the professionals / builders involved in unauthorized construction shall be submitted in the next meeting. Mr. M.M.I.Hussain Rep of ABAD dissented with the proposal and said that every person involved including those who were granted approval in relaxation of Rules & Regulations may also be taken into task.

11. Chief Controller of Buildings assured for the implementation of the Resolution No. 5/99 of the Oversee Committee in the letter and spirit.
