The draft SOP has been prepared (Annexure-III). As per the ToR (i) of the Oversee Committee, it is now the mandate of the Committee to recommend amendment in KB&TPR-2002, and other Laws of the Land. Therefore issue is placed before the forum.

3. Increase of Penalties (Amendments in SBCO)

The SBCA had submitted the proposed amendments in SBCO in three different summaries. The two summaries have been approved by the Chief Minister and one is pending in Law Deptt: (Annexure-IV). It is proposed that keeping in view the ongoing reforms in SBCO, the all three proposals be consolidated and the increase in penalties (amount & imprisonment) with any further suggestion may be obtained from the forum. If agreed, the detailed working paper will be presented in next meeting.

4. Dangerous Building.

The Technical Committee on Dangerous Buildings SBCA has so far declared 468 buildings dangerous/un-safe in the Karachi region, some of them demolished but still a lot to be demolished pending due to non-cooperation from the occupants to evacuate such buildings. Around fifty (50) buildings which have been declared as dangerous/un-safe are protected Heritage sites. The cultural Heritage Dept. GOS has been informed accordingly. Majority of declared dangerous buildings are located in the old city area (Lyari & Saddar Town) whereas Liaquatabad Town has also considerable numbers.

PROBLEMS AND ISSUES

Main problem of non-evacuation of these buildings is ownership which is mostly on Good-will or tenancy basis. The occupants are reluctant to vacate knowing that they do not have the ownership rights. In December, 2016, SBCA moved a summary to the Hon CM, Sindh suggesting short term and long term measures.

It is further informed that the main issue is the rehabilitation and reconstruction of the dangerous buildings. There are multiple issues involved. At one end around 50 buildings are declared to be Dangerous, required to be demolished under the provisions of SBCO, whereas Sindh Cultural and Heritage Act 1994 requires the buildings to be the protected Heritage. Acquisition of Land and earning the trust of the occupants is the main challenge. Besides the allowable floor area ratio viz constructed floor area also differs which need to be

worked out holistically. The most suitable arrangement for addressing the issue and to attract private expertise / capital is through Public Private Partnership arrangement under Public Private Partnership Framework. The execution of proposed model can be taken up under Sindh Special Development Board Act 2014. The matter is placed before the Committee for recommendations.
